Record **Achievements**

9,554 Volunteers

After volunteering, nine out of ten reported feeling more engaged in and proud of our community

LAST YEAR'S RECORD = 6,070 / HISTORICAL AVERAGE = 1,702





21,415 Volunteer Hours

Equates to a community benefit of \$368,985 LAST YEAR'S RECORD = 15,321 / HISTORICAL AVERAGE = 3,785



9,007 People Educated

Eclipsing the previous 33% record, 50% of our environmental education activities incorporated service-learning elements LAST YEAR'S RECORD = 9,979 / HISTORICAL AVERAGE = 4,508



474 Litter Cleanup Events

Resulted in 5,000+ bags of litter collected (trash & recyclables) LAST YEAR'S RECORD = 423 / HISTORICAL AVERAGE = 113



2,931 Storm Drains Marked

Volunteers installed "no dumping" decals on storm drains and distributed water pollution prevention door hangers

LAST YEAR'S RECORD = 1,903 / HISTORICAL AVERAGE = 1,371

Successes Worth Celebrating



TREES FOR OMAHA

Launched this multi-year, native-tree planting program to combat the loss of ash trees from the invasive Emerald Ash Borer. 618 trees were planted in 11 city parks.



OMAHA SPRING CLEANUP

Supported the City of Omaha and approximately 100 neighborhood associations with this event, resulting in 1,315 tons of bulky material diverted for proper disposal and recycling.



YOUTH FALL CLEANUP

A total of 1,741 youth and adults participated in this citywide KOB event, almost doubling last year's record of 935 participants.



TEACHER TRAININGS

Conducted classes for local educators to become certified in various environmental education curricula (e.g., Growing Up Wild).



COLLECTIVE FOR YOUTH

Partnered with Civic Nebraska to provide out-of-school-time environmental education programming as part of the Collective For Youth initiative at Lewis & Clark Middle School.



WORLD O! WATER

Assisted the City of Omaha in coordinating the World 0! Water festival; 1,500+ people attended and learned about water conservation, pollution prevention, and safe recreation.



GLASS RECYCLING

Secured a grant from the Nebraska Department of Environmental Quality to continue promoting glass recycling and purchase/deploy an additional collection container.



TIRE RECYCLING

Helped the City of Omaha conduct a tire recycling event in which 3,028 scrap tires were collected.



VACANT LOT REVITALIZATION

Worked with 200 volunteers and residents to plant additional rain & pollinator gardens on a city-owned vacant lot; property is now used for educational activities by KOB and local organizations/schools.





Additional Accomplishments


- Continued to implement our 2017-19 strategic plan and achieved the majority of our year-two objectives

- In partnership with the Douglas County Treasurer's Office, shredded and recycled 2.75 tons of used license plates

- Conducted a structured, community-wide litter index demonstrating reductions in littering behavior
- · Increased the number of Adopt-a-Park partners to an all-time high
